There are a lot of hikers in the gorge at weekends, so you have to expect traffic jams on the narrow ladders. The protection is rather modest, there are usually two unconnected bolts with a latch, one of which has a tight screw link. Pulling off the rope is often a feat of strength. At the exit, the cashier realized that we were canyoneers and brashly claimed that canyoning was forbidden in the canyon. The Alpine Club had told her this and it was also written on the signs on the ticket office. Now be very strong, the ancient sign says: "Climbing in the gorge area on both sides up to the watershed is officially prohibited from the Kassierhütte to the gorge exit - Bezirkshauptmannschaft Bruck". She refused to accept my objection that we were neither climbing nor had we left the streambed. I will investigate further to clarify the legal situation. (machine translated)
