( <a href="https://www.tnp.si/en/visiting-park/activities-and-sights/water-sports/canyoning/">https://www.tnp.si/en/visiting-park/activities-and-sights/water-sports/canyoning/</a> )<br>On request (2025) by email ( <a href="mailto:triglavski-narodni-park@tnp.si">triglavski-narodni-park@tnp.si</a> ) to the park administration, the procedure was described as follows:<br><br>"For canyoning in the canyons in the Triglav National Park (TNP), EVERYBODY needs TNP Authority Consent (Permission).<br>Among other differences between commercial and, as in your case - private visit, the difference is that for a private visit you don't need a white water rescuer to be with you.<br>For getting the Consent, we first need the data below to put you into the system. Upon that you'll receive username and password to log into the app and apply for the Consent.<br>On application/Consent "covers" maximum 5 (private) visitors. For each visit you have to pay 3 eur/person.<br>Data we need to put you in the system:<br>-Name<br>-Surname<br>-Address<br>-Phone number<br>Usually all this procedure takes more then one working day (no weekends), please bear that in mind when planning" |  |                                      |
| <b>Hidrología:</b>  |  |                                      |
| <b>Acceso:</b> (traducción alternativa)<br>Freeway exit Tarvisio. Direction Slovenia/Bovec. Cross the IT/SLOW mountain border (Predil Pass). After the border crossing follow the road downhill towards Bovec. Just before Log Pod Mangartom (between Podnji Log and Stmec na Predlu) there is a bridge over the Predelica river. Immediately after that, turn left into a gravel driveway that ends after about 100m. Here you have a large parking area and you can already see the upper part of the canyon.   |  |                                      |

**Acceso:** (traducción alternativa)

From the parking lot (approx. 620Hm) it goes first over the streambed to a small meadow (clearing) here you also have an insight into the last part of the gorge --> at this point you follow the hiking trail left up --> after a few meters of altitude you can already see the 50m waterfall (water level) --> from here continue climbing for about 20min and then right to the entry/streambed (approx. 800Hm).

**Recorrido:** (traducción alternativa)

At the beginning you have short walking and climbing passages. After a short time there are the first small rappels which are mastered without much effort --> the canyon is very open and sunny in the upper part --> once you have warmed up and left the first rappel behind, you come to an impressive 50m waterfall with a good chain anchor (!sharp edge) --> in the first third you are directly in the water steel. After that you rappel in the overhang --> after this point comes a short walking passage --> now the canyon is cut --> the tour offers until the end varied and beautiful passages with mostly smaller rappel in the water course --> shortly before the exit comes another short narrow canyon section.

**Regreso:** (traducción alternativa)

The exit is on the right directly at the meadow at the beginning of the access (approx. 620Hm) --> from the meadow again across the stream to the parking lot.

Regarding the required approval of the national park and the required registration, the following personal experience (as of season 2024): All information is available on the homepage of the Triglav National Park (<https://www.tnp.si/en/visiting-park/activities-and-sights/water-sports/canyoning/>). First, it is necessary to fill out the form "APPLICATION FOR CONSENT" and send it together with the payment confirmation of €22,60,- (administrative fee ) to the national park by e-mail. It then takes a few days to receive the online access and password for the registration application. Before you enter the respective tour, you have to register online in this app and pay €3 per person. During the day, the local guides reminded us several times that we needed a permit for the tour.
